Operate under the same federal laws as the mainland U.S., including FDA, USDA, and IP protections.

2 COST-EFFECTIVE MANUFACTURING

Competitive labor costs 30%-40% lower than mainland U.S. and generous tax incentives reduce operational expenses.

- No U.S. federal tax on Puerto Rico sourced income.
- Up to 50% tax credit on qualified R&D expenditures.
